The Licensed User/Company is required to register all labor with the Hawaii Theatre Production Manager prior to access. To ascertain the amount of time and manpower required for the production work desired and to schedule specific times for load-in, setup, rehearsals and load-out, COMPANY should contact the Theatre Production Manager. The Theatre reserves the right to deny authorization to any stage crew members who, in the opinion of the Hawaii Theatre General Manager, do not meet the Hawaii Theatre Qualification Guidelines.

3) Individuals secured to fill crew positions must be approved by the THEATRE. The THEATRE reserves the right to deny authorization to any crew members
